





### A little bit of history..

Senator William Johnson sought to share his love of learning with the people of Hackensack in the spring of 1900 by offering the community a new building and 5,000 dollars worth of new books for the establishment of a free public library.

Senator Johnson purchased the property on the corner of Main and Camden Streets, extending east to Moore Street, as the site of the soon to be constructed library. The building was worth 60,000 dollars at the time it was built. It was made of brown Belleville stone and the walls were covered with ivy. It has been enlarged since it was originally erected, but the original structure has never been torn down





Senator Johnson was so devoted to establishing a public library for the town of Hackensack that, as part of the deed giving the property to the Library Trustees, Senator Johnson included the provision that the property would revert to the Trustees of Princeton University (Senator Johnson's alma mater) if the property ceased to be used as a free public library for the people of Hackensack.

In November of 1902 the children's room (now administrative offices) opened for use. Johnson Public Library was one of the first public libraries to have a separate room for children.

Mr. John Eugene Morrow was the first janitor and an ordained minister. His daughter, Nellie K. Morrow Parker, for whom the school is named, became northern New Jersey's first African-American educator in 1922. John's eldest son, Eugene, was the second African-American to graduate from Hackensack High School, in the year 1917. Another son, E. Frederic Morrow, was President Eisenhower's executive assistant – the first African-American in the history of the United States to achieve this position (lozza & Steuerwald, 1994).

However, other than cosmetic updates to the Main Street Plaza and exterior around 2000, and a few changes of carpet, paint and furniture, the Library remains in the same state as it was six decades ago.

## Capital projects 2018-2025



A previously underutilized stacks room was turned into our beautiful gallery in 2021 thanks to the hard work of our staff and new flooring. We added additional HVAC to the space in 2024 as it is now used for some of our larger events including Youth Arts Month.



In 2022, with the support of The Hackensack Rotary, we opened The Lawn as a public park.

2024 - The Library completed its first Community Development Block Grant project, combining two small restrooms into one accessible family restroom. This is the first ADA renovation of any of the library's facilities, and only the second time that the library has been renovated since the major addition in the 1960s.



The Library finished a sprinkler installation over the last few years and is finally in compliance with fire code.

We also applied for and received an 800k incentive from PSEG and were able to replace all of the lighting, HVAC and install a new boiler. This was an over 1M project, the balance we will pay back over 5 years with no interest.





The library added 1,256 new cardholders in 2024.

We are open 62 hours per week and host over 1,000 programs per year. All programs are free of charge.


Public bidding took place and the lowest responsible bidder was H&M Company LLC. Their winning bid of 769,000 does not include the furniture and technology necessary to get the space ready for public use, which we estimate dollars was higher than expected but does include the cost to remove a large amount of asbestos tile. This figure will be approximately 150,000 additional dollars. Thankfully, this work will only necessitate a short closure during asbestos abatement and demolition. We hope to stay open throughout most of the project, and operate with almost all of our services available. Work should be completed around February of 2026. This project is being funded by a charitable gift as well as the Library's














### CITY OF HACKENSACK ORDINANCE NO. 46-2025

### AN ORDINANCE AMENDING CHAPTER 37 OF THE CODE OF THE CITY OF HACKENSACK "RULES OF ORDER"

WHEREAS, pursuant to N.J.S.A. 40:48-2, the governing body of a municipality may make, amend, repeal, and enforce such other ordinances, regulations, rules and by-laws not contrary to the laws of this state or of the United States, as it may deem necessary and proper for the good of government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any law; and

WHEREAS, the City of Hackensack City Council ("City Council") wishes to amend the City of Hackensack Municipal Code ("City Code") Chapter 37 entitled "Rules of Order" in order to publish and utilize a consistent method of conducting business at City Council meetings; and

WHEREAS, the City Council finds that it is within the public interest to enact rules of procedure for public meetings; and

**NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF HACKENSACK, as follows:** 

### **Section 1:**

Chapter 37, Section 13 of the Code of the City of Hackensack is hereby amended as follows [additions by <u>underline</u>, deletions by <u>strikethrough</u>]:

### §37-13 Meetings; Scheduling and Notice.

- A. Regular Meetings. Regular meetings must be held at least twice per month at a time designated by the Council pursuant to N.J.S.A. 40:81-19. The Mayor and Council may cancel regular meetings for any reason.
  - i. Scheduling regular meetings. Pursuant to N.J.S.A. 10:4-18, at least once each year, the Council shall post and maintain posted throughout the year in the place described in Subsection (E)(iii), for the purpose of public inspection, a schedule of the regular meetings of the Council to be held during the succeeding year.
  - ii. Requests for notices of meetings. Pursuant to N.J.S.A. 10:4-19, any person may request that a public body mail to him copies of any regular meeting schedule or revision described in Subsection (A)(i) herein and any advance written notice as described herein by Subsection (E) regarding any regular, special or rescheduled meeting of such body. The Council may, by resolution, fix a reasonable amount to cover the costs of providing such notice. Upon prepayment by such person of a reasonable sum, the public body shall cause written advance notice of all of its meetings to be mailed to such person within the time prescribed herein by Subsection (E).

- C. Meetings of a committee of the whole must be held in accordance with Robert's Rules of Order and are subject to the same notice requirements provided herein for regular meetings.

### Section 2:

Chapter 37, Section 14 of the Code of the City of Hackensack is hereby amended as follows [additions by <u>underline</u>, deletions by <u>strikethrough</u>]:

### §37-14 Meetings Procedure.

- A. [UNCHANGED]
- B. Resolutions and Ordinances.
  - Every resolution or ordinance shall be reduced to writing and <u>ordinances shall be</u> read before the vote is taken thereon pursuant to N.J.S.A. 40:81-20. <u>All resolutions on a consent agenda may be read as a list by resolution numbers as long as the resolutions are made available in writing and displayed at the meeting at which the consent agenda is acted. Any member of the municipal council may request that any resolution(s) on the consent agenda be removed from the consent agenda and voted on separately.</u>
  - ii. Pursuant to N.J.S.A. 40:81-21, no ordinance passed by the Council shall go into effect before ten (10) days from the time of its final passage, except when:
  - a. Otherwise required by the general laws of the state; or
  - b. It is an ordinance for the immediate preservation of the public order, peace, health or safety, or to remedy an emergency caused by fire, flood, explosion, storm, epidemic, recovery of judgment, the act of God or the public enemy, which may be passed to take effect immediately without publication and at one meeting, by the vote of one more than a majority of the members of the Council.
- C. Voting, generally. The vote upon every motion, resolution, or ordinance shall be taken by yeas and nays and entered into the minutes. Upon the discretion of the Mayor, certain pro forma motions may be called by acclamation unless a Council Member votes nay, and in which case, a roll call shall be performed.
- D. Call to Order and Order of Business. Organization generally. The Mayor shall be the presiding officer, and shall call the meeting to order by determining that a quorum is present. He/she shall take the chair and announce that the meeting will come to order. This may be followed by other opening ceremonies and the Mayor may request to go out of order at his/her discretion. The following represents the sequence in which business is to be introduced:
  - i. Reading and approval of minutes;
  - ii. Reports of officers, boards, and standing committees;
  - iii. Reports of special committees;
  - iv. Special orders;
  - v. Unfinished business and general orders;
  - vi. New business; and
  - vii. Public comment.
    - I. <u>CALL TO ORDER AND ORDER OF BUISINESS: including the Open Public Meetings Act statement, roll call, flag salute, and approval of minutes.</u>
    - II. RESOLUTION CALLING FOR EXECUTIVE SESSION

### **Section 3:**

All other provisions of Chapter 37 of the Code of the City of Hackensack shall remain unchanged.

### Section 4:

Repeal of Inconsistent Provisions. All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

### Section 5:

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason is held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remain in effect; it being the legislative intent this Ordinance shall stand notwithstanding the invalidity of any part.

### Section 6:

Codification. This Ordinance shall be a part of the Code of the City of Hackensack as though codified and fully set forth therein. The City Clerk shall have this ordinance codified and incorporated in the official copies of the Code. The City Clerk and the City Attorney are authorized and directed to change any Chapter, Article and/or Section number of the Code of the City of Hackensack in the event that the codification of this Ordinance reveals that there is a conflict between the numbers and the existing Code, and in order to avoid confusion and possible accidental repealers of existing provisions not intended to be repealed.

### Section 7:

This Ordinance shall take effect upon passage, adoption, and publication in the manner prescribed by law.

### **ORDINANCE #47-2025**

BOND ORDINANCE PROVIDING AN APPROPRIATION OF \$1,320,000, PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS AND ACQUISITIONS IN AND FOR THE CITY OF HACKENSACK, IN THE COUNTY OF BERGEN, NEW JERSEY AND AUTHORIZING THE ISSUANCE OF \$1,254,000 BONDS OR NOTES OF THE CITY FOR FINANCING PART OF THE APPROPRIATION.

BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF HACKENSACK, IN THE COUNTY OF BERGEN, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

### SECTION 1:

The improvements described in Section 3 of this bond ordinance (the "Improvements") are hereby authorized to be undertaken by the City of Hackensack, New Jersey (the "City") as general improvements. For the said Improvements there is hereby appropriated the amount of \$1,320,000, such sum includes the sum of \$66,000 as the down payment (the "Down Payment") required by the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes, as amended and supplemented (the "Local Bond Law"). The Down Payment is now available by virtue of provision in one or more previously adopted budgets for down payments for capital improvement purposes.

### **SECTION 2:**

In order to finance the additional cost of the Improvements not covered by application of the Down Payment, negotiable bonds of the City are hereby authorized to be issued in the principal amount of \$1,254,000 pursuant to the provisions of the Local Bond Law (the "Bonds"). In anticipation of the issuance of the Bonds and to temporarily finance said Improvements, negotiable bond anticipation notes of the City are hereby authorized to be issued in the principal amount not exceeding \$1,254,000 pursuant to the provisions of the Local Bond Law (the "Bond Anticipation Notes" or "Notes").

### **SECTION 3:**

(a) The Improvements authorized and the purposes for which obligations are to be issued, the estimated cost of each Improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each Improvement and the period of usefulness of each Improvement are as follows:

- (b) The estimated maximum amount of Bonds or Notes to be issued for the purpose of financing a portion of the cost of the Improvements is \$1,254,000.
- (c) The estimated cost of the Improvements is \$1,320,000 which amount represents the initial appropriation made by the City. The excess of the appropriations made for each of the Improvements over the estimated maximum amount of Bonds or Notes authorized to be issued therefor as stated above is the amount of the Down Payment.

### **SECTION 4.**

All Bond Anticipation Notes issued hereunder shall mature at such times as may be determined by the municipal finance officer of the City (the "Chief Financial Officer"); provided that no Note shall mature later than one year from its date. The Notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with Notes issued pursuant to this ordinance, and the signature of the Chief Financial Officer upon the Notes shall be conclusive evidence as to all such determinations. All Notes issued hereunder may be renewed from time to time subject to the provisions of Section 8(a) of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the Notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the City Council of the City at the meeting next succeeding the date when any sale or delivery of the Notes pursuant to this ordinance is made. Such report must

include the amount, the description, the interest rate and the maturity schedule of the Notes sold, the price obtained and the name of the purchaser.

### **SECTION 5:**

The capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey is on file with the City Clerk and is available for public inspection.

### SECTION 6:

The following additional matters are hereby determined, declared, recited and stated:

- (a) The Improvements described in Section 3 of this bond ordinance are not current expenses, and are capital improvements or properties that the City may lawfully make or acquire as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The average period of usefulness of the Improvements, within the limitations of the Local Bond Law, taking into consideration the respective amounts of all obligations authorized for the several purposes, according to the reasonable life thereof computed from the date of the Bonds authorized by this bond ordinance, is 7.95 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the City Clerk and a complete executed duplicate thereof has been filed in the office of the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey. Such statement shows that the gross debt of the City, as defined in the Local Bond Law, is increased by the authorization of the Bonds and Notes provided in this bond ordinance by \$1,254,000 and the obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.
- (d) An aggregate amount not exceeding \$125,000 for items of expense listed in and permitted under Section 20 of the Local Bond Law is included in the estimated cost of the Improvements, as indicated herein.

### **SECTION 7:**

Any funds received from time to time by the City as contributions in aid of financing the purposes described in Section 3 of this Ordinance shall be used for financing said Improvements by application thereof either to direct payment of the cost of said Improvements or to the payment or reduction of the authorization of the obligations of the City authorized therefor by this Bond Ordinance. Any such funds received may, and all such funds so received which are not required for direct payment of the cost of said Improvements shall, be held and applied by the City as funds applicable only to the payment of obligations of the City authorized by this Bond Ordinance.

### **SECTION 8:**

The full faith and credit of the City are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the City, and the City shall be obligated to levy ad valorem taxes upon all the taxable property within the City for the payment of the obligations and the interest thereon without limitation of rate or amount.

### SECTION 9:

The Chief Financial Officer of the City is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the City and to execute such disclosure document on behalf of the City. The Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the City pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the City and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the City fails to comply with its undertaking, the City shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking

### SECTION10:

This Bond Ordinance constitutes a declaration of official intent under Treasury Regulation Section 1.150-2. The City reasonably expects to pay expenditures with respect to the Improvements prior to the date that City incurs debt obligations under this Bond Ordinance. The City reasonably expects to reimburse such expenditures with the proceeds of debt to be incurred by the City under this Bond Ordinance. The maximum principal amount of debt expected to be issued for payment of the costs of the Improvements is \$1,254,000.

### **SECTION 11:**

Introduced:

This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

### CITY OF HACKENSACK ORDINANCE NO. 48-2025

### AN ORDINANCE TO AMEND CHAPTER 155 OF THE CODE OF THE CITY OF HACKENSACK, "TAXICABS" TO UPDATE SECTION 5, "INURANCE" TO REFLECT CURRENT REGULATIONS

WHEREAS, the New Jersey Legislature adopted amendments to N.J.S.A. 48:16-3 to increase the insurance requirements for commercial vehicles including taxis to \$1,500,000.00; and

WHEREAS, the new Jersey Legislature adopted S-2841 on January 8, 2024 to have an effective date of July 1, 2024, which increased the insurance requirement to \$1,500,000.00; and

WHEREAS, it is necessary to amend the Code of the City of Hackensack, Chapter 155, entitled "Taxicabs," Section 5 "Insurance" to comply with the amendments of N.J.S.A 48:16-3.

**NOW, THEREFORE, BE IT ORDAINED** BY THE CITY COUNCIL OF THE CITY OF HACKENSACK, as follows:

### **Section 1:**

Chapter 155, Section 5 of the Code of the City of Hackensack is hereby amended as follows [additions by underline]

### §155-5 Insurance

B. Such policy shall be conditioned for payment of a sum of not less than \$100,000 to satisfy all claims for damages by reason of bodily injury to or the death of any one person; and a sum of not less than \$300,000 to satisfy all claims for damage by reason of bodily injury to or the death of all persons resulting from accident by reason of the ownership, operation, maintenance or use of the vehicle to be licensed; and a sum of not less than \$1,000 to satisfy all claims for damages to property of any one person resulting from such accident; and a sum of not less than \$5,000 to satisfy all claims for damages to property of all persons on account of any such accident by reason of the ownership, operation, maintenance or use of such vehicle. Insurance required. The owner of the taxicab shall have filed with the City of Hackensack an insurance policy which shall be issued by an admitted insurance company duly licensed to transact business in the State of New Jersey, the policy providing for not less than \$1.5 million to satisfy all claims for damages, by reason of bodily injury to, of the death of, any person or persons, resulting from, or on account of, an accident, by reason of the ownership. operation, maintenance, or use of such taxicab upon any public street; and to satisfy any claim for damages to property of any person or persons, resulting from, or on account of, an accident, by reason of the ownership. operation, maintenance, or use of such taxicab upon any public street. Nothing contained in this subsection shall prohibit the owner of a taxicab from obtaining any additional amount of motor vehicle liability insurance coverage from a company licensed outside the State of New Jersey.

### Section 2:

All other provisions of Chapter 155, Section 5 of the Code of the City of Hackensack shall remain unchanged.

### Section 3:

Repeal of Inconsistent Provisions. All ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

### Section 4:

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason is held to be invalid or unconstitutional by a court of competent jurisdiction,

such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remain in effect; it being the legislative intent this Ordinance shall stand notwithstanding the invalidity of any part.

#### Section 5:

Codification. This Ordinance shall be a part of the Code of the City of Hackensack as though codified and fully set forth therein. The City Clerk shall have this ordinance codified and incorporated in the official copies of the Code. The City Clerk and the City Attorney are authorized and directed to change any Chapter, Article and/or Section number of the Code of the City of Hackensack in the event that the codification of this Ordinance reveals that there is a conflict between the numbers and the existing Code, and in order to avoid confusion and possible accidental repealers of existing provisions not intended to be repealed.

#### Section 6:

This Ordinance shall take effect upon passage, adoption, and publication in the manner prescribed by law.

#### 1. Finding / Condition: (Repeat)

Significant progress was noted in this area; Remaining tasks include 1) comparison of Edmunds system trust ledgers to individual bank accounts, and 2) required cancellations by resolution and remittance to Current Fund

#### Recommendation:

#1 (Repeat) That balances in dormant developer's escrows be cancelled by resolution and remitted to the Current Fund.

#### **Explanation and Corrective Action:**

During 2024 a total of 75 inactive, dormant escrow accounts with no balance were closed. These dormant bank accounts with no balance will continue to be closed. Once completed, dormant bank accounts with a balance will be researched and cancelled by resolution of the governing body and the funds remitted to the Current Fund.

#### **Implementation Date:**

Dec. 31, 2026

#### 2. Finding / Condition: (Repeat)

The fixed asset accounting and reporting system was not maintained in accordance with N.J.A.C. 5:30-5.6.

#### Recommendation:

#2 That the Fixed Asset accounting and reporting system be maintained in accordance with N.J.A.C. 5:30-5.6.

#### **Explanation and Corrective Action:**

A physical inventory of the City's fixed assets has not been conducted since before the Covid pandemic due to the exposure limitations implemented because of the pandemic. A full physical inventory of the City's fixed assets needs to be conducted by an outside firm to comply with this directive. This inventory will then be imported into the Edmunds Fixed Asset module and will be continuously updated through the purchase order / encumbrance system.

#### **Implementation Date:**

Dec. 31, 2026

#### 3. Finding / Condition:

The special improvement district levy was not properly incorporated into the Edmunds tax collection system.

#### Recommendation:

#3 That the Tax Collector properly incorporate the special improvement district levy into the Edmunds tax collection system.

#### **Explanation and Corrective Action:**

The Tax Collector currently maintains the special improvement district tax levy on an Excel spreadsheet. Research needs to be done to see how it can be incorporated into the Edmunds tax collection system. The Excel spreadsheet will still be maintained as a check for errors.

#### **Implementation Date:**

Dec. 31, 2025

#### 4. Finding / Condition:

Recreation fees were not established by local ordinance.

#### Recommendation:

#4 That all recreation fees be established by local ordinance.

#### **Explanation and Corrective Action:**

On March 19, 2024 the City adopted Ordinance #06-2024 which included the balance of previously non-codified Recreation fees.

#### **Implementation Date:**

Already implemented

#### 5. Finding / Condition:

There were instances of fees being waived without authorization or existence of internal controls.

#### Recommendation:

#5 That internal controls be established for the waiver of recreation fees.

#### **Explanation and Corrective Action:**

In 2024 a system was developed for waiving the fee for certain Recreation programs for families without the means to pay for the registration. This process is currently overseen by the Office of the City Manager, but will be reviewed again for possible modification.

#### **Implementation Date:**

Already implemented

#### 6. Finding / Condition:

A formal policy for economic hardships was not implemented.

#### Recommendation:

#6 That the Mayor and Council adopt formal policies for waiving of Recreation fees due to economic hardship.

#### **Explanation and Corrective Action:**

In 2024 a system was developed by the City Manager to waive certain Recreation registration fees to families without the means to pay. This process will be reviewed for formal action by the Mayor and Council.

#### **Implementation Date:**

Dec. 31, 2025

#### 7. Finding / Condition:

Interest was not accrued on utility debt.

#### Recommendation:

#7 That interest be accrued on utility fund debt

#### **Explanation and Corrective Action:**

The accrued interest from the 2024 Parking Utility serial bond was omitted from the 2024 Parking Utility Trial Balance on the Annual Financial Statement (AFS). The AFS was corrected and re-uploaded into FAST on October 14, 2024.
